It has come to the notice that the family pension jointly notified to the spouse of the pension is not being paid even after submitting the death certificate.

It is advised that in such cases, family pension may be commenced immediately on receipt of his/her request duly supported by the death certificate. Thereafter, the report there-of is required to be submitted to AUDIT Section of this office.
